Notice of Complete Application for and Public Informational Hearing for Proposed Grading and Stream Realignment

Flambeau Mining Company, N4100 Hwy 27, Ladysmith, WI 54848 has applied to the Department of Natural Resources for a permit to realign less than 500 hundred feet of and grade more than 10,000 square feet on the bank of an unnamed tributary to the Flambeau River, locally known as stream C.

The applicant proposes to:

Remove and convert a wet detention basin (referred to as a biofilter) to an infiltration basin Construct two new infiltration basins

Remove approximately 300 feet of existing rail spur and convert the area to wetland Alter existing drainage swales to direct water to the infiltration basins Fill approximately 500 square feet of wetlands to realign stream C.

The project is located in Section 9, Township 34 North, Range 6 West, City of Ladysmith, Rusk County.

The public hearing is scheduled for: Wednesday August 3rd 2011, at the WDNR Service Center N4103 State Highway 27, Ladysmith Wisconsin 54848 at 5:00 PM.

The Department has determined that the application is complete and is currently evaluating the applicant's proposal. The Department will also be conducting a public informational hearing where individuals can learn more about the proposed activity and submit written or oral comments about the waterway and project in light of the standards below. The Department must consider factual information about the following legal standards in deciding whether to issue, modify, or deny the approval or permit to the applicant:

- Whether there is detriment to the public interest, including fish and wildlife or their habitat, natural scenic beauty or water quality
- The activity will not cause environmental pollution as defined in s. 299.01(4)
- Whether material injury will result to the riparian rights of any riparian owners of real property that abuts any water body that is affected by the activity
- Whether the applicant is the owner of any land upon which the change in course or straightening of the navigable stream will occur
- Whether the proposed change of course or straightening of the navigable stream will improve the economic and aesthetic value of the applicants land
- Whether the flood flow capacity of a stream is adversely affected
- Whether the proposed change of course or straightening of the navigable stream will be detrimental to the rights of other riparian owners located on the stream or all of the these riparian owners have consented to the issuance of the permit

The Department will follow the steps below to reach its final decision on the application:

- 1. Review the plans and information provided by the applicant.
- Review the information from public comments.
- 3. Review the information presented at a public informational hearing if one is requested.
- Review the information found in natural resource inventories and plans, maps, or data collected by the Department or others using commonly accepted methods.
- Determine whether the proposed project or activity complies with s. 1.11, Stats [the Wisconsin Environmental Policy Act], and ch. NR 150, Wis. Adm. Code.

The Department has made a tentative determination that it will issue a permit with conditions for the proposed project.

Reasonable accommodation, including the provision of informational material in an alternative format, will be provided for qualified individuals with disabilities upon request.

Any member of the public may submit written comments to the address above by U.S. mail. Comments shall include the docket number or applicant name, and shall relate to whether the project meets the legal standards listed above. Comments shall be postmarked no later than 10 days after the date that the public informational hearing is completed.

Pursuant to s. 30.208(3)(e), Stats, within 30 days after the public hearing is held, the department shall render a decision that approves, modifies or denies the permit that is the subject of the application by mailing its decision to the applicant.

The final decision may be appealed as indicated in the decision document.


